ENGAGEMENT – THE NEW JARGON

There's an old saying along the lines "**be careful what you wish for as you may actually get it**" and that may very well be true of the consultation processes wished for by the public. For years people complained that Councils took decisions which had a major impact on their way of life and their services, without a word of consultation. So Councils were required to adopt Consultation Policies and actions which mandated consultation on many aspects of their decision-making.

Decisions that used to be routinely made by Councils as an elected government are now subjected to long-winded and often tokenistic processes of public scrutiny; business slows down and bold decision-making often suffers.

Council is currently involved in public consultation on ▪ Adelaide Central Market Review ▪ New Royal Adelaide Hospital Park Lands Lease Agreement ▪ Bonython Park Activity Hub ▪ Proposed Changes to By-Laws ▪ Building Inspection Policy Review and we have just completed consultations on ▪ 10 Year Activity Plan ▪ Rundle Mall By-Law ▪ Adelaide Outdoor Markets Review and ▪ Park Lands Landscape Master Plan. Altogether in 2010 some 29 consultations were undertaken.

The cost to the Council of all this consultation is enormous but the cost to the community is immeasurable. I have spoken to a number of representative community organisations over recent months all of whom say that they are suffering extreme strain on their voluntary resources, almost to the point of burn-out, in trying to respond to all these consultations in an informed and meaningful way; and soon we will be calling for responses on the **Business Plan and Budget** together with other strategic plans which need to be taken as an integrated whole having regard to the **State's 30 Year Plan.**



I am sure that the private sector, which often accuses Councils of moving too slowly, wouldn't tolerate this level of intervention in its decision-making processes nor be prepared to subject itself to the same levels of transparency.

Of course many of the subjects of these consultations are very important and quite properly open to full stakeholder scrutiny **but perhaps we have got more than we wished for**, perhaps it is time to revisit the whole process of public consultation to ensure that we use our limited resources to the best effect. Council is revamping its **Consultation Policy** and the first step is to adopt some new jargon. Recognising that the word 'consultation' implies that a two-way exchange of ideas is going to occur - which very seldom actually occurs - the experts have dreamt up a more nebulous term for the process which is now to be called 'Engagement' which actually is a quite meaningless term, unless of course you're in the business of engaging!

LATE NEWS – CONGRATULATIONS to the State Government for its bold move to review licensing hours and other matters affecting the sale of liquor. Whilst it is not all that the Council was asking for, what is proposed should go a long way to restoring a balance between reasonable entertainment opportunities and responsible drinking behaviour. In particular it will give the people of the West End a chance to build an economy which is balanced between day time and night time activities.

- **12. City Design and Character Committee - 1 March** (Chair:Cllr Llewellyn-Smith)

1. Council resolved to advise the Minister that the **Better Development Plan** sought by him would be covered by Council's Section 30 Review. 2. Council endorsed an **Integrated Community Engagement Strategy** for public consultation. 3. It was resolved to not agree to the Minister's request to withdraw the City Heritage and Character Residential and Main Street (Hutt) Zones-Part 2 Dev Plan Amendment Report 4. **Park Lands project priorities for 2011-2012** were adopted. 5. It was agreed to adopt a **1-way traffic scheme** for **Prince Court** (Waymouth to Albert) and 6. a review of parking controls in **Beaumont Rd and South Tce** was deferred to allow for a further study of parking patterns and needs in that part of the city.

- **13. City Development and Sustainability Committee - 1 March** (Chair:Cllr Plumridge)

-1. Council noted a report on options for the future operation of the **Precinct Groups** and decided to retain the present model for 2011-2012. A **Main St/Precinct Ref. Group** was set up comprising the **Lord Mayor and Cllrs Williamson & Wilkinson**.

2. Council approved, for public comment, the **Adelaide Central Market** Draft Charter and a Central Market Reference Group was set up on an interim basis. Members appointed were the **Lord Mayor and Cllrs Hender, Abiad and Henningsen**.

-3. Council adopted a strategy for **Outdoor Markets** in the City noting that its future role would be primarily as a facilitator.

-4. Council adopted the **Climate Change Adaptation Action Plan** for 2011-2013. 6. Council agreed to subsidise on a one-for-one basis one member of each Precinct Group to attend the coming **Main Street Conference** in Adelaide in May.

- **14. Community Services, Events and Facilities Committee - 8 March** (Chair: Cllr Clearihan)

-1. Council noted the outcomes of the **City Presentation Task Force** and appointed members to the expanded Task Force.

-2. It was agreed that proposed changes to reduce the **Connector Bus Service**, as proposed by the Administration, would not be implemented until the matter had been considered by the committee at its April meeting.

- **15. Corporate Planning, Governance and Finance Committee - 8 March** (Chair: Cllr Hamilton)

-2. Council adopted the principles for determining a **Tree's Amenity Value**. Operational details are to be brought to Council.

-3. The idea of separate rate levies for **East and West End** commercial properties has been referred to the Precinct Review.

- **16. Corporate Planning, Governance and Finance Committee -15 March** (Chair:Cllr Hamilton)

-1 Council adopted, for the purposes of 'building the budget', major and minor **Strategic Capital Enhancement Projects**.
