SHOULD ADELAIDE BECOME A SLOW CITY?

The Lord Mayor has been calling for Adelaide to slow-down by adopting lower speed limits in the CBD. By adopting 40 kph we could dramatically improve the quality of life in the city, fewer road accidents, safer conditions for cyclists and pedestrians and a generally more pleasant environment.

But why stop at just lowering speed limits? Almost every aspect of life would improve if we could just slow down and take the time to 'smell the roses'. Many other cities around the world have taken the plunge, what about Adelaide?

Fired by the success and support for Slow Food the Italians set about initiating the Slow Cities movement. Slow cities are characterised by a way of life that supports people who choose to live slow. Traditions and traditional ways of doing things are valued. These cities stand up against the fast-lane, homogenised world so often seen in other cities throughout the world. Slow cities have less traffic, less noise, fewer crowds.

Slow City rules say that no town or city with more than 50,000 residents may apply to be called a Slow City. The Slow City manifesto contains 55 pledges or criteria, grouped into six categories upon which cities are assessed; ■ environmental policy, ■ infrastructure, ■ quality of urban fabric, ■ encouragement of local produce and products, ■ hospitality and community and ■ Slow City awareness. To qualify to be called a Slow City and to use the **snail logo**, a city must be vetted and regularly checked by inspectors to make sure it is living up to the Slow City standard of conduct.



"There are a number of examples in Adelaide that indicate an openness for the idea of slowness. The number of farmers markets have increased dramatically and the options to buy organic food are increasing and there is an enthusiasm for home-grown produce. Urban design has become more concerned about **placemaking and human interactions**.


Green building designs, sustainable urban development, growth management, and other measures to contribute to a greener environment are becoming more commonplace. THE POWER OF 10

The Power of 10 is a concept the organisation "Projects for Public Spaces" uses to highlight principles of the **Placemaking Process**. The basic idea is that it's not enough to have just **one** great place in a neighborhood—you need a number of them to create a truly lively neighborhood. And it's not enough to have only one top-notch neighborhood - you need to provide people all over town, close to home chances to take pleasure in public life.

Any Great Place itself needs to offer at least 10 things to do or 10 reasons to be there. These could include a place to sit, playgrounds to enjoy, art to touch, music to hear, food to eat, history to experience, and people to meet. Ideally, some of these activities are unique to that spot and are interesting enough to keep people coming back. Local people who use the space most regularly are the best source of ideas for what uses will work best.



How many quality places are located in the City and how are they joined up? What are your 10 Places in the City?

COUNCIL MEETING – Chaired by A/Lord Mayor - 20 Dec (Next Meeting 31 Jan – All Committees 24 Jan. at 5.30)

A/Lord Mayor's report presented the **Draft Riverbank Master Plan** and Council resolved its **'in principle'** response.

7.Petition containing 108 signatures objecting to D/A for **Queens Head Hotel** was received and the objection therein noted.

Questions on Notice 10. Cllr **Hamilton** re significant tree removal at **Adelaide Oval** and **11** re Location of **Survey Marker.**

 - 2. Council endorsed the proposed CLMP Framework and the **Kurrangga (Park 20)** plan for consultation and feedback.
 - 3. Council noted that Administration is exploring ways to encourage upgrades of public spaces around major developments.
 - 4. Heritage Grants were approved for **Greenways Apartments** (\$33.5k) and the **S. Dome of Adelaide Arcade** (\$62.5k)
 - 6. Council endorsed a **Park Lands funding model** for recurrent (moving towards 50% ACC) and enhancement funding .
 - 8. Council endorsed the intended scope of a confidential response to State Government **Housing Strategy** Green Paper.
 - 9. Council endorsed the **Francis St** Concept Plan to be developed as a joint project with the Pacific Group (Rundle Place).
 - 10. It was agreed to 5-yr lease, subject to consultation, of land near the Old Gaol for 130 RAH worker car parks for \$292.5k.
 - 11. Alterations to **Connector Bus Route** were adopted to improve timekeeping, and to start as soon as possible in 2012.
