## COUNCIL MEETING - Meeting held 13 November (Next Ordinary Meeting 27 Nov 6pm – Cées Grp 2 –20 Nov 5.30)

### ■ 1. Apologies and Leave of Absence

- Cllr Abiad was on leave of absence and Cllrs Henningsen and Clearihan were apologies. Cllr Abiad was granted a further leave of absence from Council and Committee meetings for the period 6 November until 16 December 2012.

### ■ 2. Confirmation of Minutes

- Minutes of the meetings of Council held on 23 and 30 October and 6 November were confirmed as correct records.

### ■ 3. Deputation

- David Williams, Chair of the **East End Coordination Group** reported on the **Main Street SA Awards** and pointed out that of the 11 awards in various categories, 8 had been won by Adelaide City Council projects including 6 in the East End.

### ■ 4. Report of the City Planning and Development Committee – 6 November (Presented by Chair, Cllr Llewellyn-Smith)

- 4.1 Council endorsed the MoU with other Councils for implementation of the **R. Torrens Linear Park Management Plan**.
- 4.2 Council agreed to the **closure of George St** (Hindley St to North Tce) to allow for the exclusion of all vehicles.
- 4.3 The First Quarterly Progress Report on the **Climate Change Action Initiatives Fund 2012/13** was noted. Council is on track to achieve the targets for carbon emissions, energy consumption and Green Power set in the Energy Man<sup>t</sup> Plan. Council also resolved to become a Project Partner in the **CRC for Low Carbon Living project “Urban Microclimates”**
- 4.4 Council approved a retrospective **Heritage Grant of \$17,739** for work at **74 Kingston Tce North Adelaide**.
- 4.5 Council advised SA Health that it was satisfied with their **draft Management Plan** for land holdings in the P/Lands **associated with the new RAH** and requested the State Government to return two parcels of land to the Council.
- 4.6 It was resolved that the function of granting concurrence to **non-complying developments** remain with the Council.
- 4.7 Council made decisions dealing with **Pre-Lodgment Agreements** under the provisions of the Development Act 1993.

### ■ 5. Report of the City Culture and Community Services Committee – 6 November (Presented by Chair Cllr Clearihan)

- 5.1. Council made grants totaling **\$44,360** in Round 2 of the 2012- 2013 **Arts and Living Culture Grants Program**.
- 5.2. Council made grants totaling **\$58,650** in Round 2 of the 2012- 2013 **Recreation and Sports Grants Program** with the grant of \$50k to the SA Rugby League for floodlighting at Victoria Park being deferred for further consideration.
- 5.3 Council made grants totaling **\$78,100** in Round 2 of the 2012- 2013 **Community Development Grants Programs**.
- 5.4 **Disability Planning Review** - Council endorsed the draft Access and Inclusion Strategy as attached to the agenda.
- 5.5 Council noted the **By-Law 3 (Unauthorised Camping) Operating Guidelines** and endorsed implementation of the Guidelines, from 1 December. This will require Park Lands campers to vacate following a reasonable offer of housing.

### ■ 6 Advice of the Adelaide Park Lands Authority held on 8 November 2012

Council noted advice from the Authority as follows: (NB the advice in (2) has been included in item 4.5 above)

#### 1. **War Memorial Drive West – Road Reserve/Park Lands Boundary**

That the Surveyor General be advised that for the basis of for a survey, the boundaries of the road reserve be set at 3 metres either side of the existing bitumen carriageway.

#### 2. That Council advise SA Health that it is satisfied with their **draft Management Plan** for land holdings in the P/Lands **associated with the new RAH** and request the State Government to return two parcels of land to the Council.

- 7. Council resolved to advise the LGA and Minister John Rau of its serious concern at proposals to allow private certification of development applications as provided for in the **Development (Private Certification) Amendment Bill 2012**
- 8. Council elected **Cllr Llewellyn-Smith** to be **Deputy Lord Mayor (DLM)** from 6 Dec 2012 until the end of January 2014 I congratulate Cllr Llewellyn-Smith on his appointment and acknowledge Council's support during my 2 years as the DLM
- 9. Committee Chairs were elected: - City Planning & Development – **Cllr Malani**. City Culture & Community Services – **Cllr Hender**, City Infrastructure & Public Works – **deferred** and Finance & Corporate Governance – **Cllr Abiad**.
